ORDER:

As per the Andhra Pradesh Unaided Non-Minority Professional Institutions [Regulation of Admissions into Under-graduate and Pharm-D (Doctor of Pharmacy) Professional Courses through Common Entrance Test] Rules, 2011 issued, vide the G.O. 1st read above, and amended from time to time by the Government, the Government shall notify the fee for both Category-A and Category-B seats.

2. As per the Andhra Pradesh Higher Education Regulatory and Monitoring Commission Rules, 2019 issued, vide the G.O. 2nd read above and amended from time to time, by the Government, the Andhra Pradesh Higher Education Regulatory and Monitoring Commission (APHERMC) has the power to review and determine the fee to be collected by Higher Educational Institutions for both Category-A and Category-B seats.

3. The circumstances reported by Secretary, APHERMC vide his letter read 3rd read above, the Government, after careful examination of the matter, hereby permit the Private Unaided Non-Minority Professional Institutions offering Under-graduate Engineering / Pharmacy and Pharm.D (Doctor of Pharmacy) courses to collect the tuition fee for the management quota seats to a maximum of three(3) times to the fee notified by the Government for Category-A seats of the respective program in respective institutions so as to enable the institutions to maintain quality and standard of education by providing infrastructural and instructional facilities and amenities, subject to the condition that the higher education institutions shall intimate the fee to be collected for the management quota well in advance before the academic year to the Government, APHERMC, Counseling Authority and the concerned University so as to enable transparency and notify the fee to the prospective students.

NOTIFICATION

In exercise of the powers conferred under Section 7 of 'Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983' (Act No.5 of 1983), the Government hereby notify the fee as follows for the Category-B Seats which shall be admitted as per the 'Andhra Pradesh Unaided Non-Minority Professional Institutions [Regulation of Admissions into Under-graduate and Pharm-D (Doctor of Pharmacy) Professional Courses through Common Entrance Test] Rules, 2011' as amended from time to time:

"The Private Unaided Non-Minority Professional Institutions offering Under-graduate Engineering/Pharmacy and Pharm.D (Doctor of Pharmacy) courses can fix the fee for Category-B seats not exceeding the below specified limits separately for each branch/program of study and the same shall be displayed in the 'Single Window portal for Category-B Seats' well before conducting the counseling for Category-B seats:

- a. for Category-B NRI quota seats up to USD 5000\$ and
- b. for Category-B Non-NRI seats, up to three (3) times to the fee notified by the Government for Category-A seats of the respective program in the respective institution."
